



## **PUPIL PREMIUM**

**Did you know that registering your child for 'Pupil Premium' means that our school is able to claim funding to provide extra resources for your child?**

**This money can make a big difference to your child's education and we use it provide extra resources and support that we would not otherwise be able to afford.**

### **What is Pupil Premium?**

'Pupil Premium' funding is an extra amount of money paid direct to the school from the government for every child, who meets any of the following criteria:

- Pupils eligible for a Free School Meal (see explanation below)
- Children adopted from care, along with children who left care under a Residence Order on or after 14 October 1991, and those that left care under a Special Guardianship Order on or after 30 December 2005
- Pupils who have a parent in the armed forces or who has been in the last five years.

### **How does it work?**

1. Check if you qualify using the three bullet points above.
2. Children adopted from care and children with a parent in the armed forces:  
Please speak to your child's class teacher or Mrs Oustayiannis, Headteacher, in confidence if your child has been adopted from care or if a parent is in the armed forces (see above).
3. Children whose parents may be eligible to claim for Free School Meals:  
Since September 2014 all children in Reception, Year 1 and Year 2 have been entitled to receive a Free School Meal every day. However, if you get any of the benefits below you can register your child for free school meals which will provide the school with much needed funds. We don't get this funding if you don't apply. Registration is confidential and it will not affect any other benefits you are claiming.  
You can register your child for free school meals if you are entitled to any of these benefits:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on - paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit

You can apply for 'Free School Meals' by one of the following methods:

- By completing an application form (available from the school office) and posting it to Warwickshire County Council

To complete an application you will need to provide:

- Your own name and date of birth
- Contact details
- National Insurance Number or National Asylum Seekers Number
- Child's name and date of birth
- Our school name

### **Additional benefits we offer families whose child(ren) are eligible**

At Telford Infant School we also use the grant to pay for the following for eligible children:

- £50 towards school uniform to be spent at any time during the academic year. We will purchase these on your behalf from the online School Uniform Shop.
- All learning visits (trips)
- Free school milk (which is normally chargeable when a child reaches 5 years old)
